Accessory Solar Energy System (ASES)/Principal Solar Energy System (PSES) Initial Application Deposit	The Applicant for ASES or PSES approval shall deliver to the Cherrytree Township Secretary, along with its Application and other required fees, an amount equal to 1% (one percent) of the estimated cost of the project (an Initial Deposit) for use by the Township to reimburse the Township for expenses incurred for consultants and attorneys to provide assistance in the Application review process. These funds shall be administered in accord with Section 5.36(2) of the Zoning Ordinance.	1% of estimated project cost

	<p>Applicants for road permits must pay the township a \$50.00 fee per truck and post a performance or surety bond, or, in lieu thereof, a certified check or irrevocable letter of credit, naming the township as payee, in the amount specified above, depending upon use, to be held by the township for any and all road repairs that are needed as a direct result of their operations. An exception to this procedure may be made at the discretion of the Roadmaster or the Board of Supervisors when it is determined that the applicant will conduct any operation that involves excessive long-term projects, heavy truck, drilling, or construction projects that may result in significant damage above and beyond the routine hauling damage amounts.</p>	
Road Boring	\$70.00 (\$50.00 permit fee + \$20.00 inspection fee)	
Driveway Installation	Resident must purchase pipe from an outside source, according to specifications set forth by the Roadmaster, and notify the township when the pipe has been delivered and is ready for installation. For installation and gravel, the township will charge the resident \$50.00 per every 10 feet of pipe (20 feet is \$100.00, 30 feet is \$150.00).
