

Cherrytree Township Board of Supervisors  
Special Meeting  
May 11, 2015

A special meeting of the Cherrytree Township Board of Supervisors was held on Monday, May 11, 2015, at 5:00 p.m., at the township building. In attendance were Roger Patterson, Lew Staub, and Emery Fiely, Supervisors, and Christine Kurelowech, Secretary-Treasurer.

**Call To Order**

Roger Patterson called the meeting to order.

**Public Comment**

There was no public comment.

**Administrative Action**

Discussion was held about the township's finances. Lew Staub suggested not doing any seal coating this year, cutting back on dust oil as much as possible, and waiting until August to purchase gravel.

**2015 Seal Coating – Review Bids**

Bids to apply a bituminous single seal coat (SRL-L, polymer modified) to approximately 1.2 miles of Hamilton Corners Road, .4 of a mile of Old Petroleum Center Road, and .7 of a mile of Breedtown Road were reviewed and discussed. The areas on Hamilton Corners Road and Old Petroleum Center Road are located just off Route 8 and the area on Breedtown Road begins at the intersection of Cherrytree Road and runs east. Bids were received from Russell Standard Corp., Jefferson Paving Corp., and Suit-Kote Corp. The bid results are attached. On a motion made by Roger Patterson, seconded by Lew Staub, and carried, the Supervisors voted to reject all of the bids submitted. They will seek phone quotes to seal coat the .7-mile stretch on Breedtown Road that was paved in 2014. On a motion made by Lew Staub, seconded by Emery Fiely, and carried, the Supervisors agreed to have the .7-mile stretch on Breedtown Road (paved in 2014) seal coated if the phone quotes are less than \$10,000.00.

**2015 E-1 Prime Bidding – 50,000 Gallons - Review Bids**

Bids for approximately 50,000 gallons of E-1 Prime (dust suppressant), to be pressure applied to various roads, were reviewed and discussed. Bids were received from Russell Standard Corp., Suit-Kote Corp., and Midland Asphalt Inc. The bid results are attached. On a motion made by Roger Patterson, seconded by Emery Fiely, and carried, the Supervisors voted to accept the lowest bid (\$73,500.00), submitted by Midland Asphalt Inc., for approximately 50,000 gallons of E-1 Prime (dust suppressant) to be pressure applied to various roads.

**Old Business**

**Stormwater Management**

Roger Patterson reported that he recently discussed Ken Humanic's construction project with Jason Ruggiero, of the Venango County Regional Planning Commission, and a stormwater permit will not be necessary because Mr. Humanic is simply replacing part of an existing building. A zoning permit and a building permit will be required.

The meeting adjourned at 5:40 p.m.
